HOW WE ROLL: At Northside we represent three things that matter a lot to us; #1 is God!, #2 is the Church, and #3 is ourselves. Proper behavior and following instruction of the Youth Leaders is important and will represent our Church and God in the right way. If a student does not represent God, our Church, or themselves in a proper manner, then they are subject to hanging out with one of the Youth Leaders for the rest of the day and forfeiting their right to participate. Please have your student represent their best behavior and respect during this outing. There should be no issues, as our Youth Group is insanely blessed by incredible families, but the expectation needs to be established. Our goal is to provide an incredibly fun day at the lake create memories and connections with the youth group for His glory.

WAIVER: Given the nature of “EPIC LAKE DAY,” there are inherent and acknowledged risks in voluntarily participating in these activities (swimming, riding in boats, riding on inner-tubes, and other “lake” activities). Therefore, by signing below the parent/guardian understands and acknowledges these risks. All activities out on the boats will require lifejackets to be worn. Any swimming outside of the designated Foster swimming area will also require life jackets. Supervision around the dock area and swimming area will be by adults. Boat drivers are certified to operate their vessel and boat driver instructions will be followed at all times, or privileges to ride in the boats will be revoked. Parents/Guardians assume all risk of injury to participants. Having read this waiver, and in consideration of participation in the Epic Lake Day event, guardians release Northside Christian Church, the Elder team, youth leaders, volunteers, insurers, boat drivers, and all other agents from liability, including liability arising from negligence of persons named in this waiver or others on the lake. It is Northside Christian Church’s intent to create the safest environment possible while participants enjoy the activities already mentioned. Safety is our number 1 priority in these type of activities, experienced boat drivers and normal lake day activities will occur. No abnormal lake day risk activities will be allowed. By signing below, you acknowledge that you have read and understand the terms of the waiver and liability release and are freely and voluntarily signing this agreement.

PARENTS: As a parent, I understand the risks involved with an Epic Lake Day at Foster Lake and release Youth Leaders, boat drivers, other supervising adults, Elders, and Northside Christian Church of any liability should an accident occur. I give Jim Atkins, and other Youth Leaders at Northside permission to seek medical attention for my child, if deemed necessary by a doctor. I understanding that every attempt will be made to reach out to you, as a Parent/Guardian at the numbers listed above.
